

BISX is pleased to announce its BISX All-Share Index and trading statistics for the three-month period ending March 31, 2024 with comparison to the same period of 2023.


BISX ALL SHARE INDEX

For the three-month period ending March 31, 2024 the BISX All-Share Index closed at 2,937.08. This represents a year to date increase of 85.44 or 3.00%. By comparison, for the three-month period ending March 31, 2023 the BISX All-Share Index closed at 2,397.37. This represented a year to date decrease of 247.69 or 9.36%. The BISX All-Share Index is a market capitalization weighted index comprised of all primary market listings excluding debt securities.

As at March 31, 2024 the market was comprised of 20 ordinary shares with a market capitalization of \$6.42 Billion. In addition, there were 4 preference shares with a market capitalization of \$60 million, 5 BGS and Corporate Bonds with a face value of \$349 Million and 242 BGRS with a face value of \$4.4 Billion.

MARKET CAPITAL

Over the 3-year period 2022 to 2024, the market value of all securities listed on BISX has shown an increase.


For the three-month period ending March 31, 2024, each type of security produced the totals in the chart below:


TRADING VOLUMES AND VALUES

AVERAGE DAILY VOLUME AND VALUE

For the three-month period from January 1, 2024 to March 31, 2024, the average volume per trading day was 12,473 shares for a value of \$166,546.02. By comparison, for the three-month period from January 2, 2023 to March 31, 2023, the average volume per trading day was 24,413 shares for a value of \$467,422.51
